These rules passed both committees in the House and Senate and will be implemented upon the adjournment of the Idaho legislative session. Our proposal for our Electrical License also passed the legislature. Getting this electrical issue as far as we have has been an exhausting uphill battle for at least 10 years. The Strawman Initiative (S1083aa) that I am sure many of you know about, looks like it will not be affecting our industry at all. But your Board of Directors will keep a sharp eye out as it progresses.

I would like to welcome Sam Kingrey and Kenny Vollmer back on the board as well as our new M&S member Seth Sheets. If you missed our annual Convention in January, you missed out on one the best ones we have had in years. Attendance was at an all time high. Great informative classes as well as the

Riverside did an excellent job with the food this year. None of this would happened without our Exective Director Mr. Roger Batt with the help of Cassidey Plum. Your help setting up and running the convention, vender area, Presenters and the travel, lodging and coordinating of the convention in general was incredible. The board can't thank you enough. Garrett Post has been elected as our new Vice President. He and I as with the rest of the Board will strive to represent all of you as best we can.

## **Executive Director Report**

In January the Idaho Ground Water Association hosted a successful and well-attended Annual Convention at the Riverside Hotel in Boise. There was a record attendance of about 280 people in and 32 exhibits for the tradeshow. Presentations included Idaho, Oregon, and Washington Rules & Regulations, Well Rehabilitation and Development, Engineering a Better Filter Pack, Dave Farmer's presentation on "When Things go to Crap", Advanced Drilling Tools, hands on Pump Troubleshooting classes, and many others. A total of 12 credits were available for those who were able to attend the Convention including 2 hours of Idaho Rules and Regulations. The Association also elected Bill Tanner as the IGWA President and Garrett Post as the IGWA Vice President.

The IGWA also hosted an Eastern Idaho Workshop in Pocatello on February 27 and a Virtual Workshop on March 7. Both Workshops were awarded 6 credits including 1 hour of Idaho Rules and Regulations license holders.

I'm proud to report that the IGWA had a very successful 2025 Idaho Legislative Session. The Association was able to get both sets of Rules passed for changing the Low Temperature Geothermal standard from 85 degrees to 140 degrees and to get the Electrical Exam for domestic pump installers. Both sets of Rules will go into effect upon adjournment of the Legislative Session. The IGWA will be soon working with the Idaho Division of Professional Licensing on drafting the new Exam for domestic pump installers.

If there are other issues you would like for the Association to work on, please don't

hesitate to contact the IGWA office so we can help you and your business be more successful. In the meantime if you need any additional credits for your license we are still offering some online courses through the IGWA website. We will be working on getting new material onto the website over the next few weeks.

## IDAHO DEPARTMENT OF WATER RESOURCES

Greetings,

It was great to see those who attended the Idaho Ground Water Association's (IGWA) annual convention in Boise. Idaho Department of Water Resources ("Department") appreciates the opportunity to participate, it appears this year's presentations were well received, and we hope that each of you walked away thinking about the topics the department covered. Below are a few takeaways:

- All drilling applications are now required to be submitted through the Web-Based Drilling Application.
- Driller's reports must be sent to the department within 30 days of completing a well. License renewals will not be approved if a drilling company has late or missing driller's reports.
- Driller's reports are a legal and permanent record and used for hydrologic/geologic analysis and research. Please make sure each driller's report is complete and accurately describes the hydrogeologic conditions encountered in the well bore.
- Artesian wells, both flowing and non-flowing as defined in Idaho Code, require a full depth seal or a surface seal and formation seal to protect the confined aguifer characteristics.

Driller license renewal season is officially here, all company licenses, driller licenses, and operator permits expiring on March 31, 2025, are invalid as of April 1, 2025, unless renewed for the upcoming license period. In mid-February the department will mail renewal notices directing you to the appropriate fillable forms available on the IDWR website. To maintain a valid license without interruption please have complete renewal packets submitted to the Department no later than March 15th. Please submit your renewal application in a single filing, including the required bond, proof of continuing education credits, fees and renewal form. Incomplete applications will not be processed. Feel free to contact the department at (208) 287-4800 if you have any questions.

Your application should include the following items:

- 1. **A Cover Letter:** The cover letter should include the name of the sponsoring IGWA member and your relationship. Why you are applying for the scholarship, and include your plans for further education: where you plan to attend school, anticipated major or focus of study or vocational plans.
- 2. School Transcript (required)
- 3. **School Involvement:** This might include school clubs, offices held, sports, expressive arts (music, drama, ect.) and committees.
- 4. Community Involvement: This might include church, clubs, organizations or activities outside of school.
- 5. **Volunteer Involvement:** List any volunteer activities, what you did and how much time you spent volunteering.
- 6. **Work Experience:** If you worked please let us know where you worked and for how long. Include practical work and family business experience.
- 7. Honors, Awards and Recognition: Tell us about any academic, music, service or other awards.
- 8. Three Letters of Recommendation: At least one must be from someone other than a teacher.
- 9. **Headshot & Bio:** Please attach a bio and headshot with your application. Write a short description of your current accomplishments in college and your future plans. The bio should not exceed 200 words. Save the file in a standard document format (e.g., Word or PDF). Provide a professional, high-quality image of yourself. Accepted file formats: PNG or JPG.
- 10. Recipients will be required to do a letter of appreciation with information on how the money will be used to help with your education to be read at the IGWA Convention in January.
